<b>Professional Summary</b>	<p>Antonio Angelucci is an associate professor of law and religion at the University of Insubria in Como and Varese, Italy. Having qualified as a full professor, he is also a member of the University of Insubria’s Presidium of Quality. He teaches Comparative Law of Religions, Law and Religion, Religions and Rights in a Multicultural Society, Religious Tourism (economic, legal and anthropological profiles), Religious Rights, Community and Family Mediation, and Religion, Human Rights and the UN Agenda 2030. He is also a member of the Doctoral College of Law and Human Sciences and of the Doctoral College of National Interest (DIN) in Peace Studies.</p> <p>He directs the Master’s programme for intercultural community educators at the University of Insubria and the Inter-University Research Centre “International Forum Democracy &amp; Religions” (FIDR), as well as the scientific book series “Studi sul diritto del fenomeno religioso”. He sits on the Scientific Council of the Research Centre “Religion, Law and Economics in the Mediterranean Space” (REDESM) and on the Scientific Council of the FILIS Master’s programme, and he is a member of the editorial boards of scientific journals. He is also an adjunct professor of Islamic, Hindu and Buddhist law at the University of Italian Switzerland (USI) in Lugano, and has been a visiting professor at the University of Alcalá (UAH) and the University of Coimbra.</p> <p>He was a member of the working group on the IHRA (International Holocaust Remembrance Alliance) definition of anti-Semitism at the Presidency of the Council of Ministers in Rome, and a project manager at the FIDR inter-university research centre.
